## ***“SETTLE NOT SUE”***

### The Competition

These rules shall regulate all aspects of the 3<sup>rd</sup> VIPS-Maadhyam DRCC National Virtual Mediation Competition (hereinafter referred to as “the Competition”) 2020, organized by Vivekananda School of Law and Legal Studies, VIPS DRCC (hereinafter referred to as the Organizing Committee).

**The Competition will be held from 27<sup>th</sup> August, 2020 to 30<sup>th</sup> August, 2020.**

### Aim and Purpose

Mediation is a voluntary, party centered and structured negotiation process where a neutral third party assists the parties in amicably resolving their disputes by using specialized communication and negotiation techniques. The goal of mediation is to find a mutually acceptable solution that adequately and legitimately satisfies the need, desire and interest of parties.

### Eligibility

The Competition is open to all bona fide students pursuing undergraduate degrees (five and three-year law courses) in law Schools/Colleges/Institutions/Universities only in India (hereinafter “Participating Institution”).

Each Participating Institution is permitted to send a maximum number of **two teams** in the Competition. If at all more teams are registered, that would be subject to only two teams being selected on the First Come First Serve basis.

All Participants must be registered with respective institutions as full-time or part time students for the academic year 2020-2021.

## Structure

### TEAM COMPOSITION

1. Each team shall comprise of *three students* consisting of one Mediator and two team members acting as the client-counsel pair (referred to as the “Mediating pair”).
2. One member of the team will be designated as Mediator, whose role shall remain unchanged throughout the Competition. The other two members of the team will form the Mediating pair, representing a Client and his/her Counsel. The respective roles though *not interchangeable* within a round, are changeable in different rounds.
3. The two mediators in one competition session (from different teams) for all purposes will be referred to as Mediator 1 (M1) and Mediator 2 (M2) as designated in the match-ups.

### COMPETITION STRUCTURE

4. The competition will be conducted online on the platform “**Zoom**” and the detailed rules and regulations for the same shall be sent well in advance before the competition.
5. Two Teams (Two Mediating Pair) will be the *Requesting* and *Responding Parties* respectively. The Mediating pairs and Mediators for each Session and their roles shall be decided by draw of lots.
6. Each round will have members from four different teams (four members of two teams forming two Mediating Pairs and two Mediators from different teams). To avoid any conflicts, the Mediators will not be assigned to those sessions in which the Mediating pairs belong to the same Institution as that of the Mediator. To maintain this, the Organizing Committee shall regulate the same during draw of lots.

## ➤ ROUNDS

### DRAW OF LOTS

7. The draw of lots shall be conducted on **27<sup>th</sup> August, 2020**.

### PRELIMINARY ROUND

8. The preliminary round shall be conducted through **video-conferencing**, via the platform Zoom or Google Meet (as maybe decided by the Organising Committee). The meeting Id and password will be informed to the teams through email.

9. The prelims shall be conducted on **28<sup>th</sup> August, 2020** in 2(two) different slots according to the Draw of Lots which shall be notified to the teams.

10. The competition will have one preliminary round for a period of **35 minutes** (exclusive of the preparation time provided for 15 minutes prior to the session). Followed by a post analysis session with the judges for a period of 5 minutes during which the members of all the teams will receive feedback and comments from the judges regarding the session while discussing their BATNA and mediation strategy.

### QUARTER FINALS

11. The Quarter final round shall be conducted through **video-conferencing**, via the platform Zoom. The meeting Id and password will be informed after the preliminary rounds to the teams through email.

12. The quarter finals shall be conducted on **29<sup>th</sup> August, 2020**.

13. **Eight teams** selected from the preliminary round on **Scoring basis** will qualify for the Quarter-Finals, which will be for a total period of **45 Minutes** (exclusive of the preparation time provided for 15 minutes prior to the session). Followed by a post analysis session with the judges for a period of 5 minutes.

## SEMI FINALS

14. The Semi-final round shall be conducted through **video-conferencing**, via the platform Zoom. The meeting Id and password will be informed after the Quarter final round to the teams through email.
15. The Semi-final round shall be conducted on **29<sup>th</sup> August, 2020**.
16. The four teams qualifying for Semi-Final round will be selected on **“Knock- Out” basis** from the quarter final rounds. The time limit of the Quarter Finals will be **45 minutes** (exclusive of the preparation time provided for 15 minutes). Followed by a post analysis session with the judges for a period of 5 minutes.

## FINALS

17. The Finals shall be conducted through **video-conferencing**, via the platform Zoom. The meeting Id and password will be informed after the Semi-final round to the teams through email.
18. The Finals shall be conducted on **30<sup>th</sup> August, 2020**.
19. The teams selected for finals on a **“Knock-Out” basis** from the Semi-final rounds will compete in the Finals for a total time period of **60 Minutes** (exclusive of the preparation time of 20 minutes prior to the competition session) followed by a 10 minutes post analysis session.

## CONFIDENTIAL INFORMATION

20. Each Mediating Pair will be provided separate Confidential Information **30 minutes** before the start of each session which will be their **Preparation Time**, except for the Final Rounds where a team will be given **35 Minutes Preparation Time**. The Mediator however will not be provided any Confidential Information.
21. The Mediating pairs and the Mediators will not be permitted to have any contact or communication whatsoever with each other once the Confidential Information has been provided to the mediating pair.

## BREAK(S)

22. Each Mediating pair and the Mediator may request for a **single 5-minute Break during each session**. The Team requesting the break will be responsible for adhering to the time limit. Failure will result in a penalty, as deemed fit by the Organizing Committee.
23. If a Mediating pair asks for the Break, the members of the said Mediating pair requesting the Break will be asked to move to a break room/ private room within the meeting itself.

## LANGUAGE

24. All Competition Sessions will be conducted in English. The Member (client and counsel) of the same team are allowed to speak in other languages during their breaks but only amongst themselves. They cannot converse with the mediator or the other team in any other language, besides English. However, the parties are free to use any other language whilst discussing something with a fellow team member.

## DRESS CODE

25. The dress code for the competition will be business formals. All the participants are required to adhere to the dress code.

## COMPETITION PROBLEMS

26. The Organizing Committee will be releasing the problems of all the rounds of the competition **a week prior** to the date of the Competition. In case of any changes in the schedule, the same shall be notified through the Official Facebook Page (VIPS Dispute Resolution and Client Counseling Competition) for the Competition.

## Results

28. Throughout the Competition, the Mediating pairs and Mediators will be evaluated separately and will be proceed in the rounds independent of each other. However, the **Best Team** will be based on the scores of **Preliminary rounds by cumulating the score of mediator and the mediating pair.**
29. **Best Mediator, Best Mediating Pair, Runners up Mediating Pair and Runner- up Mediator** will be based on the scores of the **Final round.**
30. The timings and meeting links for the announcement of results for every round will be emailed to all the teams in advance. All participants are requested to join the same 10 minutes prior to the start of the meeting.

## Code of Conduct

32. Participants are to conduct themselves with the required etiquette during the span of the entire competition. Reckless or irresponsible behavior by any of the team members of an institution may result in the disqualification of the entire team.
33. All or any grievances are to be presented only to the Organizing Committee of the Competition and the decision of the Organizing Committee will be final.
34. Participants shall not reveal their personal identities or that of their University to any judge or participant during the course of the competition.
35. Any attempt to obtain the Confidential Information shall render a team liable for immediate disqualification.
36. Failure to adhere to any of the time limit will result in a penalty against whomsoever the delay is attributable to. The penalty will be decided by the Judges/ Organizing Committee.

## Interpretation

38. Any question regarding the interpretation of any provision of this rule shall be subject to the decision of the Organizing Committee and any decision made by them thereon shall be final.

39. In case where marks of two or more teams are same, then marks of the constructive approach of the mediating pair will be taken into consideration. Further, in case construction approach marks are same, then marks of effective utilization of services of the mediators, will be seen.

40. In case marks of two or more mediators are the same, then marks of 'identification of issues' will be taken into consideration. Further, in case marks of identification of issues are same, then marks of 'control over the mediation session' will be seen.

41. Each team member may join the web platform from a maximum of two devices in order to ensure smooth functioning of the event in case any device stops functioning during the competition. One device shall be in the waiting room at all times while the other device is functioning. In case the device being used stops, the other device can be connected, for which 5 minutes will be given to the team, which will not be included in the allotted time. In case all devices stop working, the respective participant will be given a total time of 10 minutes to rejoin the platform and continue with the competition. During this time, the competition time will be stopped.
